Introduction

Zebra Mortgages is committed to protecting your privacy. We understand you care how your information is used and shared and we want you to feel comfortable and confident when using our website. Collecting your personal information

The information we collect from customers and website visitors helps us to personalize and continually improve your experience with Zebra Mortgages. We may collect personal information from you when you request more information, place a general enquiry via our website, subscribe to our newsletters, choose to take advantage of one of our special offers or apply for a loan. The information is being collected in accordance with the Privacy Act 2020 for all or any of the following:

- To apply or administer a loan or other application agreement,
- Enforcing payment and other legal obligation owed by me to Zebra Mortgages
- Advising you of other products and services offered by Zebra Mortgages and its associated and related companies, successors and assigns (Zebra Mortgages)
- To take up one of our special offers

You have the option to receive our newsletter and other communications but can opt-out of receiving these communications from us. We may collect information about your interaction with our site and services. For example, we use Google Analytics to analyze the use of this website and to retrieve information from your browser including the name of the domain and host from which you access the Internet; the Internet protocol (IP) address of the computer you are using; the browser software you use and your operating system; the date and time you accessed our site; and any search engine, inbound hyperlink and keywords used to reach or find our site and the pages you view within our site. We also use technologies, such as cookies to collect information about the pages you view, the links you click and other actions you take on our sites and services. Accepting a cookie will not give us access to any data on your computer other than the data stored in the cookie. You may configure your web browser to not accept cookies.

Content of any third-party website or advertisements. Third party websites are responsible for informing you about their own privacy practices. Our online advertising network partner may use cookies, web beacons or other web tracking techniques to collect non-personally identifiable information about your activities on the website and other websites that you may visit to provide you targeted advertising based upon your interests.

Are you required to provide personal information to us?

You are not required to provide any personal information to us but if you choose not to it might affect our ability to provide services to you and your ability to obtain finance, insurance and other Products from Product Providers. In most circumstances it will be necessary for us to identify you in order to successfully do business with you. However, where it is lawful and practicable to do so, we will offer you the opportunity of doing business with us without providing us with personal information, for example, if you make general inquiries about interest rates or current promotional offers. You may choose to interact with our website anonymously, but we will not be able to contact you unless you provide your personal information.

Access and correction to your personal information

You may access and request correction of any of the personal information that we hold about you at any time by contacting us. We may charge a fee for our reasonable costs of retrieving and supplying the information to you.
